##### **Parish Council Comment:**

Stanton-upon-Hine Heath parish council object to this application on the following grounds; it was only granted permission due to the link with improving local business and the site was not considered appropriate for permanent dwelling. Holiday let businesses take some time to establish, particularly in an area such as Shropshire, which is not a major tourist destination and the time since the original application was granted some 18 months ago does not seem to be nearly long enough to judge the success (or otherwise) of the enterprise therefore there is no justification for the restriction to be removed.

**Reference:** 14/02922/OUT - Outline application for the erection of 3 No detached dwellings and associated garages including access (landscaping, appearance, layout and scale reserved matters) following removal of existing agricultural buildings on Land at Village Farm, Booley Road, Stanton Upon Hine Heath, Shropshire.
