016.23 Welcome & Public Session

The Chairman, Councillor Moore, welcomed everyone to the meeting and thanked members for their confidence and support.

Public Session

Mr Floyd, Stanton Walking Group Organiser, raised concerns regarding the rights of way and paths available for walking in Stanton, which may be at risk of removal from use.

Members agreed that the Clerk should contact Shropshire Council (Rights of Way department) and confirm the routes of rights of way (as included on the Definitive Map) and discuss other regularly used paths.

Shropshire Council can consider DMMOs (definitive map modification orders) if routes have been regularly used for 20 years – evidence will be required.

Apologies had been received after the meeting and the following report submitted:

Shropshire Councillor Report

I have prepared a short report outlining the main activities across the Hodnet Division over the past 10 months. It has been an extremely busy year since my election to Shropshire Council in May 2021. In that time I have had to undertake a great deal of compulsory training as well as identifying the key Officers within the Council who I can call on for support. On a personal level I have continued to work in my full time day job and I have had to balance the needs of the two roles which has been challenging at times. I have endeavoured to attend the majority of all Parish Council meetings at Hodnet, Weston, Stoke on Tern and Stanton upon Hine Heath in order to understand local needs, share Council information and support where necessary.

At Council level there have been some core topics which are important and effect the Division including the ongoing Boundary Review, the recently approved budget for 2022 23, the allocation of funding to roads maintenance and the approval of the 3rd free recycling bin that residents are currently ordering. The Council have also had to deal with the roll out of covid vaccinations and the recent flooding from the River Severn. In Shrewsbury the Rural Relief Road and the Redevelopment of the Town Centre continue to divide opinions.

At a local level I have responded to many residents concerns regarding planning applications, road safety, noise and flooding to name a few. Where I can I have requested Officer support or arranged to meet residents and officers on site. Other key local issues that I have been involved in include; A41 Safety Campaign which is looking to improve signage and reduce speed on the A41 at Ternhill and the immediate area.

Speeding and heavy vehicle usage of rural roads across the division much of which is caused by diversions off A41 following an accident or during maintenance works. There is also a campaign for a Residents Speed Awareness group.

I have promoted the Fix My Street portal as the place to log all road maintenance issues and across the Division we have seen many of these issues being put right. Some have required an extra chase from myself.

I expect the coming year to look broadly similar but the knowledge I have gained already will help me in responding to issues raised. I will continue to push for road improvements and I expect speeding on rural roads to remain high on the agenda for local people.

RESOLVED that Stanton Upon Hine Heath Parish Council would have no objections to the proposed extension, internal reconfiguration and demolition of the bungalow.

23/01341/FUL Holly Cottage

Residential Annex

Councillor Yeadon declared an interest as a neighbour to the site

Councillors discussed the proposals at length. It was clear that this was not an annex but a self contained separate dwelling – it is not co-joined. Any development in this location must remain as part of the substantive dwelling-house. The area is designated open countryside and planning policies are in place to protect this. Members expressed concern that the applicants appear to be attempting to get planning permission for a separate dwelling 'by the back door'.

RESOLVED that Stanton Upon Hine Heath Parish Council could not support this application as it does not meet the definition and requirements of a co-joined residential annex.

c) Stanton Sundial

Councillor Dee declared an interest

The order has been placed and it is expected that a date for the work to be undertaken will be available soon.

d) Speed Indicator Device

Concerns remain regarding the speed of some traffic through the villages. Members wanted to consider the provision of a SID and sockets in various locations around the Parish. Details will be available for the next meeting. Councillor Crackett will enquire of other local councils, via NSAC, to see if they have some experience.

Other information is being collected, regarding the nearby shooting group, other organisations using the site, overnight stays, toilets etc.
